## **CONDITIONS WHICH APPLY TO PUBLIC WORKS CONTRACTS**

**PREVAILING WAGES** to be paid on Public Works Contracts: Before payment is made by the City of Pateros of any sums due for work on a public works contract, the City of Pateros must receive from the Contractor a copy of State of Intent to Pay Prevailing Wages (Form L&I No. F700-029-111) approved by Washington State Department of Labor and Industries. An Affidavit of Wages (L&I Form No. F700-007-111) approved by the Department of Labor and Industries must be submitted prior to release of five percent retained on a Public Works Contract. For contracts less than \$2,500.00, the forms and wage rate will be mailed to you by the City of Pateros. For contracts \$2,500.00 and more, the forms and wage rates can be obtained by calling Department of Labor & Industries, Employment Standards Division, (360) 753-4019.
